==PREAMBLE==

These Terms and Conditions ("Terms") explain your responsibilities and obligations relating to goods, services and information that you use or request from Synaptic Laboratories Ltd. When you use those goods, services and/or information, you must comply with these Terms. PLEASE REVIEW THE FOLLOWING TERMS AND CONDITIONS IN THIS AGREEMENT CAREFULLY BEFORE DOWNLOADING, INSTALLING OR USING THE LICENSED PRODUCT. BY: A) DOWNLOADING, INSTALLING, COPYING OR USING THE LICENSED PRODUCT; OR B) BY PAYING A LICENSE FEE TO THE LICENSOR; OR C) BY COMPLETING THIS LICENSE AGREEMENT ONLINE, You acknowledge that You have read this Agreement, understand it, accept it and agree to be bound by all its terms and conditions.

IF YOU DO NOT AGREE WITH THE TERMS AND CONDITIONS OF THIS AGREEMENT, DO NOT DOWNLOAD, COPY, INSTALL OR USE THE LICENSED PRODUCT. IF YOU HAVE ALREADY DOWNLOADED THE LICENSED PRODUCT, PLEASE UNINSTALL IT AND IRREVOCABLY DESTROY ANY COPIES YOU HAVE MADE AS SOON AS POSSIBLE. IF YOU HAVE RECEIVED A COPY OF THE LICENSED PRODUCT ON DVD OR OTHER MANNER THAN ELECTRONIC DOWNLOAD, PLEASE RETURN THE LICENSED PRODUCT UNUSED TO THE LICENSOR AS SOON AS POSSIBLE.

==DEFINITIONS==

"SLL" means Synaptic Laboratories Ltd, and its affiliated companies and subsidiaries.

"Licensed Product" includes but is not limited to software, documentation, functional cores or macros, Intellectual Property (IP) cores, field programmable gate array (FPGA) logic, NetList, tools, specifications and accompanying documentation.

"Basic Edition" and "Full Edition" means variants of the same Product, where the Full Edition will provide superior or more capabilities than the Basic Edition.

"License Assistant" means an automated process on the website of SLL whereby you can request Product Licenses and execute this Licensing Agreement.

"Acceptance and Authorisation Code" means a unique code provided to you via email while you are using the License Assistant, that you must then enter into the License Assistant online, to confirm your intention to complete a transaction, such as but not limited to licensing any SLL Product and to execute the License Agreement.

"Designated Equipment" means the computer system that is owned or leased by You and operated on Your premises and identified by a network interface card ("NIC") or host identifier ("ID") number on which the Licensed Software is installed and Used, and which has the configuration, capacity, operating system version level, and pre-requisite applications described in the Documentation as necessary for the operation of the Licensed Software, and is designated by the NIC / host ID in the License Key as the computer system on which the License Key management software will be installed.

"Seat" means the right granted under this Agreement to Use the Licensed Product by a single User in accordance with the terms and conditions of this Agreement. A Seat is either a Floating Node Seat or a Fixed Seat, which is enabled via a License Key.

"Floating Node Seat" is a license that allows the Licensed Product to be: (i) installed on and accessed from any number of computers on a network environment at one designed site; and (ii) Used by the permitted number of Concurrent Users that is equal to the number of Seats licensed as determined by the License Key, which can be a fixed number or unlimited number.

"Designated Site" means a location at which the Licensed product is approved for use.

"Fixed Seat" means a license to install the Licensed Product on a fixed standalone computer for Use by a single User.

"License Key" means a license key, license file, license manager, dongle or other key, code or information that: (i) enables a User to download, install, operate and/or regulate User access to the Licensed Product; and (ii) describes the version number of the Licensed Product and (iii) lists the number of Concurrent Users authorized to Use the Licensed Product.

"License Period" means the period of time You have Use of the Licensed Product as specified in the Quote for the Licensed Product. The License Period may also be governed by the License Key.

"Licensed Products" means any Field Programmable Gate Array (FPGA) device(s), or any FPGA Bitstream, in which the Licensed Product, in whole or in part are incorporated or implemented pursuant to the provisions of this Agreement.

"Target Application" includes but is not limited to Free Trial, R&D, Production and Channel Partner.

"Free Trial License" means a limited license that permits free evaluation of Licensed Product upon installation in FPGA device/s owned by the Licensee and prior to payment of a licensing fee, within a specified duration of time.

"R&D License" means a limited license that permits the use of Licensed Product upon installation in FPGA device/s owned by the Licensee, with or without payment of a licensing fee, within a specified duration of time, for the purposes of using the Licensed Product in the Licensees own research and development projects and activities. For example, an R&D License is required when the licensor uses SLL Soft IP in Intel's FPGA development tool, for example, when compiling SLL Soft IP into a FPGA bitstream. When more than one person or organisation collaborates on an R&D project then typically all collaborators require an SLL R&D License or a Partner and Channel Partner License, and if in any doubt then the first Licensee must contact SLL to determine the collaborators licensing obligations.

"Production License" means a license that permits use of the Licensed Product in the Licensees own products and systems that were created while using an SLL R&D License. A Production License may or may not include volume restrictions and reporting, as specified in the Quote for Licensed Product. A Production License is required for example when a company creates a FPGA bitstream that contains SLL IP, and that FPGA bitstream is used in a commercial capacity by Licensee and/or that FPGA bitstream is passed to a third party. A Production License does not permit any sub-licensing, and therefore if any recipient of the Licensees product or bitstream wants to create a bitstream that contains SLL IP then the Licensees product user, for example customer/s, itself must first request an R&D License from SLL. When more than one person or organisation collaborates on a production project then typically all collaborators that produce a FPGA bitstream that contains SLL Soft IP require an SLL Production License, and if in any doubt then the first Licensee must contact SLL to determine their collaborators licensing obligations.

"Partner and Channel Partner License" means a limited license that permits staff of SLL partner companies and their respective channel partners to use the Licensed Product solely for the purposes of a) private and public demonstration, including in but not limited to workshops, and b) for the provision of end-customer support on a customer's FPGA design, but only when that end-customer holds and first provides evidence that it holds the appropriate SLL License for the same Product, where the appropriate License during an end-customers R&D phase would be an SLL R&D License, and during manufacturing or production phase an SLL Production License.

"Support" means any support or maintenance services provided to You by SLL, an Authorized Distributor, and/or authorized SLL representatives in responding to email, telephone, or other inquiries from You for maintenance, technical, or other support requests in connection with the Licensed Product.

"Use" means downloading, installing, using and copying all or any portion of the Licensed Product into the Designated Equipment for processing the instructions contained in the Licensed Product, and/or loading data into or displaying, viewing or extracting output results from, or otherwise operating, any portion of the Licensed Product in accordance with the rights granted under this Agreement.

"User" means an individual identified by You as a person authorized to Use the Licensed Product on behalf of and for Your sole benefit.

"You" means an individual, corporation or other legal entity to which Licensor has issued a Seat or licensed the Licensed Product, as the case may be.

"Specification" means technical data in human or machine readable form furnished by the Licensor which: (i) provides operating instructions for using the Licensed Product, or (ii) explains the capabilities and functions of such items, and any full or partial copies of any such technical data.

==BODY OF AGREEMENT==

1. LICENSE GRANT

1.1 SLL is the authorised distributor of the Licensed Product.

1.3 Subject to and conditioned upon your acceptance of and compliance with the Terms and Conditions of this Agreement, including payment of any applicable license fee, SLL hereby grants to Licensee a non-exclusive, non-transferable license, with no right to sub-license, to use Product ordered by You from S/Labs, including software, documentation, functional cores or macros, Intellectual Property (IP) cores, field programmable gate array (FPGA) logic, NetList, tools and accompanying documentation (collectively, "Licensed Product"). Licensed Product

shall be used solely for the Target Application, and subject to the Designated Computer(s), seat and node limitations, as specified in the Quote that was both provided to you by S/Labs for the Product ordered by You and subsequently accepted by You (collectively, "Quote for Licensed Product"). All terms and conditions included in any Quote provided by SLL and accepted by You are incorporated by mutual Agreement into this Agreement.

1.4 Licensee agrees that Licensed Product may only be used in machine readable form, and that any node-locked ID for the Licensed Product may only be used on one physical computer, and any floating license for a single site may only be used at that site. Licensee may make up to one (1) copy of the Licensed Product (in machine readable form) solely for backup and archival purposes. Licensee agrees to ensure that copyright and other proprietary notices of SLL and its associated companies that may be present in the Product are not removed.

1.5 In all circumstances, Licensee shall ensure that all individuals that are permitted to have access to the Licensed Product have first read the full text of this licence agreement and that they understand and confirm that they shall not distribute, copy, transfer, lend, incorporate, modify or use the Licensed Product for any purpose except as expressly provided in this Agreement.

1.6 This licence is not a sale. SLL retains exclusive title and ownership of the Licensed Product, including all copyright, patent and other proprietary rights therein. SLL reserves all rights not expressly granted in and to the Licensed Product. Unauthorized copying or failure to comply with this Agreement will result in automatic termination of this Agreement and, in addition, SLL may seek all other available legal remedies.

1.7 The Quote for Licensed Product will specify the Target Application each deliverable of that Quote is licensed for. No right is granted under this Agreement to use the Licensed Product or any machine-executable, binary form of a core used to design, develop, or program on devices that are not Intel FPGA devices. You may not: (i) modify or synthesize any simulation model output files generated from or resulting from the Licensed Software; (ii) Use, and You shall prevent any third parties from using, the Licensed Software to program programmable logic devices, field programmable gate arrays ("FPGAs") application specific integrated circuits (ASICs), application specific standard products, or any other integrated circuit products designed or manufactured by any company or entity other than Intel Programmable Solutions Group or its parent or affiliated companies; and, except as otherwise permitted under this Agreement. SLL specifically disclaims any liability for results obtained when using the Licensed Product to program other FPGA devices.

1.8 Licensee shall not (and shall not allow any third party to): (a) decompile, disassemble, reduce to human readable form, reverse engineer or otherwise attempt to access, reconstruct, identify or discover any source code, underlying

ideas, concepts, techniques, methods or processes embodied therein, underlying user interface techniques or algorithms, concepts of the Licensed Product by any means whatever, or disclose any of the foregoing; (b) analyse the operation of the Licensed Product for its own competing software and/or hardware development activities; (c) host the Licensed Product acquired under a node-locked licence via the Internet or Intranet; (d) use the Licensed Product for timesharing or service bureau purposes or otherwise circumvent the use restrictions of the Licensed Product; (e) disclose the results of any evaluation and or benchmarking of the Licensed Product, without the prior written permission of SLL; or (f) attempt to circumvent any user limits or other licence, timing or use restrictions that may be in the Licensed Product.

1.9 Licensee agrees to ensure that the Licensed Product is only accessed and used by users with a need to know and use the Licensed Product for the Target Application specified in the Quote for Licensed Product.

1.10 License Key. SLL will deliver the License Key to You after Your acceptance of the Quote for Licensed Product provided to You by SLL, and after SLL's receipt of any payment and all information required to generate the License Key, including the product name and quantity of Seats licensed for the designated server or computer onto which You will install the License Key management software.

1.11 If You provide to SLL any comments or suggestions with respect to the modification, correction, improvement, or enhancement of: (i) the Licensed Product or portions thereof; (ii) any Confidential Information disclosed by SLL to You; or (iii) Licensed Product that may embody such Confidential Information (collectively, the "Feedback") then You agree to grant and hereby grant to SLL a nonexclusive, irrevocable, perpetual, worldwide, royalty-free, fully paid up right and license under any Intellectual Property Rights You may have in and to the Feedback, including but not limited to the following rights: (a) create Derivative Works of the Feedback; (b) modify, enhance, and customize the Feedback; (c) sublicense the Feedback to SLL licensees and customers; and (d) market, perform, copy, have copied, make, have made, Use, offer to sell, sell, and otherwise distribute SLL's and Your sublicensees' products including or embodying Feedback in any manner and via any media SLL chooses.

1.12 Certain features and functions of the Licensed Product may be disabled by SLL as specified in the Quote for Licensed Product and it is the Licensees responsibility to select an appropriate License for their requirements. In no event will SLL be held liable for any damages or losses to You or any third party resulting from the automatic disabling of any Product functions obtained through SLL's Product License.

1.13 When a Deliverable in the Quote for Licensed Product is "Tethered to the Quartus Programmer", then SLL grants to You, the right to: (i) evaluate the logic

designs of Devices by performing the following functions: design entry, timing, place and route, compilation and verification of logic designs for Devices; and (ii) evaluate the hardware in Devices by programming the Product into such Devices, but only for so long as the Devices are continuously connected via a programming cable to a host development computer that is running the Intel PSG development tool programmer software. Otherwise, that Deliverable will operate for a predetermined amount of time, after which that Deliverable will be automatically disabled and will be inoperable.

1.14 Ownership of Licensed Product. As between You and SLL, You acknowledge and agree that SLL has and shall have exclusive ownership of all worldwide right, title and interest in and to the Licensed Product and all Intellectual Property Rights and industrial rights associated therewith, including but not limited to enhancements, corrections, improvements, modified versions, or Derivative Works of all the foregoing, in whole or in part, whether developed or co-developed by SLL, or developed or co-developed by You. To assist SLL in perfecting its ownership rights in and to the intellectual property described in this Section, You agree to assign and hereby do assign to SLL all Intellectual Property Rights that You may otherwise have acquired in and to the intellectual property described in this Section 1.14, and You agree to assist and cooperate with SLL in all reasonable respects in: (i) any actions to establish, transfer, or maintain such ownership rights, including executing any documents associated therewith; and (ii) actions of enforcement of such ownership rights. To the extent that any rights You may have acquired cannot be assigned under applicable law (for example, moral rights) You agree to waive and hereby waive any and all rights related to the Intellectual Property Rights described in this Section 1.14, including without limitation any and all rights of identification of authorship and any and all rights of approval, restrictions or limitation on use, or subsequent modification. Except for the licenses expressly granted to You in this Agreement, no other licenses are granted to You by implication, estoppel, or otherwise, and all rights not expressly granted to You are reserved by SLL.

1.15 SLL is not and shall not be obligated to provide any maintenance, support, or training, or to provide any error corrections, updates, upgrades, new versions, other modifications, or enhancements for any Licensed Product, unless this is specifically stated and quantified in the Quote for Licensed Product. You will be responsible, at Your own expense, for providing technical support and training to Your customers and any other end users of the Licensed Product, and SLL will have no obligation to support any of the foregoing. You will be solely responsible for, and SLL shall have no obligation to honor, any warranties that You may provide to Your customers or to any other end users of the Licensed Product.

2. PRODUCT IS PROVIDED TO LICENSEE 'AS IS', WITH ALL FAULTS, AND WITH NO WARRANTY

2.1 SLL AND LICENSEE AGREE THAT SLL DOES NOT HAVE ACCESS TO ANY OR ALL OF THE SAFETY, SECURITY AND FUNCTIONAL REQUIREMENTS OF THE LICENSEE'S INTENDED R&D OR PRODUCTION USE AND APPLICATION OF THE LICENSEES OWN PRODUCT. IT IS LICENSEES SOLE RESPONSIBILITY TO SEEK AND ENSURE APPROPRIATE VERIFICATION OF THE LICENSED PRODUCTS SUITABILITY PRIOR TO USE IN ANY APPLICATION WHATSOEVER. SLL MAKES AND THE LICENSEE RECEIVES NO WARRANTIES ON THE PRODUCT, EXPRESS, IMPLIED, STATUTORY, OR IN ANY OTHER PROVISION OF THIS AGREEMENT OR COMMUNICATION WITH LICENSEE, AND SLL SPECIFICALLY DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY, SATISFACTORY QUALITY, OR FITNESS FOR A PARTICULAR PURPOSE. SLL DOES NOT WARRANT THAT THE FUNCTIONS IN THE LICENSED PRODUCT WILL MEET YOUR REQUIREMENTS. SLL DOES NOT WARRANT THAT THE OPERATION OF THE PRODUCT BY LICENSEE WILL BE UNINTERRUPTED OR FAULT AND ERROR FREE. SLL DOES NOT MAKE ANY REPRESENTATIONS REGARDING THE USE OF THE LICENSED PRODUCT FOR ACCURACY, RELIABILITY, OR OTHERWISE. SLL EXPRESSLY DISCLAIMS ALL WARRANTIES NOT EXPRESSLY STATED IN THIS AGREEMENT. EXCEPT AND TO THE EXTENT OTHERWISE PROVIDED UNDER THIS AGREEMENT, YOU ASSUME THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE LICENSED SOFTWARE AND ANY DESIGN OR PRODUCT IN WHICH THE LICENSED SOFTWARE MAY BE USED, INCLUDING, WITHOUT LIMITATION, ANY LICENSED PRODUCTS. No representation or other affirmation of fact, including but limited to statements regarding capacity, suitability for use or performance of the Licensed PRODUCT, whether made by SLL employees or otherwise, shall be deemed to be a warranty for any purpose or give rise to any liability of SLL whatsoever. 3. PROPRIETARY INFORMATION, CONFIDENTIALITY, NO SUB-LICENSING AND NO TRANSFER

3.1 Licensee hereby acknowledges and agrees that the Product, including but not limited to the structure and logic of individual software programs and/or hardware modules, algorithms, concepts, interactions and techniques, methods and processes embodied therein, whether provided in source code or binary form, including any modifications, derivatives, updates and upgrades thereto, and

specifications related thereto, and any information which, at the time of disclosure, is designated in writing as confidential or proprietary, or similar designation, is disclosed in circumstances of confidence, or would be reasonably understood by a person exercising business judgment, to be confidential, hereinafter collectively referred to as the "Confidential Information", is and shall be treated as confidential information and a proprietary trade secret of SLL, the unauthorized disclosure of which would cause irreparable harm to SLL.

3.2 The Confidential Information constitutes trade secrets and confidential and proprietary information of SLL, and You agree not to access or Use the Licensed Product or portions thereof, directly or indirectly, except and to the extent expressly permitted under this Agreement and The Quote for Licensed Product or by applicable law. SLL retains all rights in and to the Licensed Product, modifications, derivatives, updates, and upgrades, and all Intellectual Property Rights associated with any of the foregoing. No other rights or licenses are granted by implication, estoppel or otherwise, to You or any third party.

3.3 You may not publish or disclose the results of any benchmarking or testing of the Licensed Product or portions thereof, without the prior written permission of SLL. Furthermore You may not use such results for Your own competing software development activities, without the prior written permission of SLL.

3.4 Licensee shall use the same degree of care that it uses to protect its own information of a similar nature, and in any event, shall use reasonable efforts to prevent the disclosure of Confidential Information to any third parties.

3.5 Licensee shall not use, reproduce, or distribute the Confidential Information other than for the purposes authorized by this Agreement and the Quote for Licensed Product

3.6 You may not sublicense or transfer the Confidential Information Licensed Product and any rights granted to You under this Agreement.

3.7 You may not sublicense, delegate, assign, or otherwise transfer possession or control of this Agreement or any of the rights or obligations contained therein to a third party without SLL's written consent. Any attempt to do so will be void and shall have no force and effect, and shall automatically and immediately terminate all licenses and rights granted under this Agreement.

3.8 This confidentiality obligation shall continue to apply to the Confidential Information following the termination or expiration of this Agreement, except to the extent of any Confidential Information which Licensee can conclusively demonstrate (a) was already in Licensee's possession at the time of receiving the same from SLL without any obligation of confidentiality as shown by Licensee's prior records; (b) is published or becomes available within the public domain

otherwise than as a consequence of a breach by Licensee of its obligation not to disclose any of the Confidential Information; (c) was lawfully received by Licensee from a third party without restriction on disclosure or use; (d) is independently developed without any breach of this Agreement by Licensee's personnel who have not had access to any of the Confidential Information; or (e) is approved in writing by SLL for release or other use by Licensee according to terms stipulated in such approval.

3.9 Intellectual Property Rights Notices. Any copies of the Licensed Product made by or for You shall include all intellectual Property Rights notices. You will not, and shall cause Your Authorized Contractors and its customers and/or end users not to, remove any SLL Intellectual Property Rights notices or other proprietary markings from the Licensed Product. Any copy of the Licensed Product or portions thereof, including but not limited to any modified versions, Derivative Works, any portion merged into a design, and/or any design or product that incorporates all or any portion of the Licensed Product, will continue to be subject to the terms and conditions of this Agreement.

4. LIMITATION OF LIABILITY

4.1 LICENSEE AGREES THAT SLL'S LIABILITY UNDER THIS AGREEMENT, REGARDLESS OF THE FORM OF ACTION, SHALL IN NO EVENT EXCEED THE PRICE OF THE LICENCE OF THE SLL PRODUCTS PAID BY LICENSEE. 4.2 YOU UNDERSTAND AND AGREE THAT THE LICENSED PRODUCT MAY BE FUNCTION-TIME, OR CLOCK CYCLE LIMITED, AND THEREFORE YOU ACKNOWLEDGE AND AGREE THAT IN NO EVENT WILL SLL BE HELD LIABLE FOR ANY DAMAGES, LOSSES, COSTS, LIABILITIES OR EXPENSES TO YOU OR TO ANY THIRD PARTY ARISING FROM OR RELATING TO THE AUTOMATIC DISABLING OF ANY LICENSED PRODUCT FUNCTIONS.

4.3 No Indirect Damages. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, UNDER NO CIRCUMSTANCES WILL SLL BE LIABLE TO

YOU OR TO ANY THIRD PARTY FOR ANY INDIRECT, CONSEQUENTIAL, INCIDENTAL, PUNITIVE, OR SPECIAL DAMAGES OF ANY KIND OR NATURE INCLUDING BUT NOT LIMITED TO LOSS OF PROFITS, LOSS OR INACCURACY OF DATA, LOSS OF USE, COSTS OF PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES IN CONNECTION WITH THE SUBJECT MATTER OF THIS AGREEMENT OR USE OF THE LICENSED SOFTWARE, IN WHOLE OR IN PART, UNDER ANY THEORY OF LIABILITY, EVEN IF SUCH LOSSES WERE REASONABLY FORESEEABLE OR SLL HAS BEEN ADVISED OF THE POSSIBILITY OF OCCURRENCE OF SUCH DAMAGES.

4.4 Damages and Indemnity Cap. IN NO EVENT SHALL SLL'S TOTAL AGGREGATE LIABILITY UNDER THIS AGREEMENT EXCEED THE LICENSE FEE ACTUALLY PAID BY YOU TO SLL FOR THE SPECIFIC LICENSE GIVING RISE TO THE CLAIM FOR THE PRECEDING ONE (1) YEAR PERIOD.

4.5 Failure of Essential Purpose. WITHOUT LIMITING THE FOREGOING, IT IS EXPRESSLY UNDERSTOOD AND AGREED BY THE PARTIES HERETO THAT EACH AND EVERY PROVISION OF THIS AGREEMENT WHICH PROVIDES FOR A LIMITATION OF LIABILITY, DISCLAIMER OF WARRANTY OR EXCLUSION OF DAMAGES IS INTENDED BY THE PARTIES TO BE SEVERABLE AND INDEPENDENT OF ANY OTHER SUCH PROVISION. FURTHER, IN THE EVENT THAT ANY REMEDY HEREUNDER IS DETERMINED TO HAVE FAILED OF ITS ESSENTIAL PURPOSE, ALL LIMITATIONS OF LIABILITY AND EXCLUSIONS OF DAMAGES SHALL REMAIN IN EFFECT, TO THE MAXIMUM EFFECT PERMITTED BY APPLICABLE LAW.

4.6 Hazardous Applications and Uses. THE LICENSED SOFTWARE IS NOT INTENDED OR DESIGNED TO BE FAIL-SAFE FOR USE IN ANY APPLICATION REQUIRING FAIL-SAFE PERFORMANCE, SUCH AS LIFE SUPPORT, SAFETY OR MEDICAL DEVICE SYSTEMS, NUCLEAR FACILITIES, OR ANY OTHER APPLICATIONS THAT COULD LEAD TO DEATH, PERSONAL INJURY, OR SEVERE PROPERTY OR ENVIRONMENTAL DAMAGE (COLLECTIVELY, "HAZARDOUS APPLICATIONS"). THE LICENSED SOFTWARE IS ALSO NOT DESIGNED OR INTENDED FOR USE WITH ANY APPLICATIONS THAT CONTROL VEHICLES OR AIRCRAFT. YOU AGREE THAT PRIOR TO USING OR DISTRIBUTING ANY SYSTEMS DEVELOPED BY USE OF THE LICENSED SOFTWARE OR THAT INCORPORATE A PORTION OF THE LICENSED SOFTWARE, TO THOROUGHLY TEST SUCH SYSTEMS FOR SAFETY PURPOSES. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, YOU ASSUME ALL RISK AND LIABILITY FOR ANY HAZARDOUS APPLICATIONS AND USES IN APPLICATIONS THAT CONTROL VEHICLES OR AIRCRAFT.

4.7 SLL is willing to enter into this Agreement only in consideration of and in reliance of the terms and conditions contained herein limiting SLL's exposure to liability. Such provisions constitute an essential part of the bargain underlying this

Agreement and have been reflected in the consideration hereto. The parties understand and agree that the provision of free trial and/or free R&D licenses and the amount of license fees paid and the exclusion of warranties, limitation of liability, and the limitation of remedies allocate risks between the parties as authorized under applicable law.

5. TERM AND TERMINATION

5.1 This Agreement is effective until terminated. Licensee's licence/s and any rights granted under this Agreement will terminate automatically without notice from SLL a) at the end of the authorised License period specified in the accepted Quote for Licensed Product, unless SLL and the Licensee have renewed the license term by entering and executing a new Quote for Licensed Product, or b) if Licensee fails to comply with any material term or condition of this Agreement. For all Licenses except Production licenses, upon termination of this Agreement, Licensee shall cease all use of the Product and destroy all copies, full or partial (to include any backups) of the Product. For Production Licenses, You shall not continue to use the Licensed Product or any portion thereof in research, development or production after termination of the Agreement, but You may keep a single copy of the Licensed Product solely for archival purposes, or to provide support to end users or customers.

6. GENERAL

6.1 Governing Law/Venue. This Agreement will in all respects be governed by, and construed and interpreted under, the laws of the United States of America and the State of Delaware, without reference to conflict of laws principles. The parties agree that the United Nations Convention on Contracts for the International Sale of Goods (1980) is specifically excluded from and will not apply to this Agreement. All disputes arising out of or related to this Agreement will be subject to the exclusive jurisdiction of the courts of the State of Delaware or of the Federal courts sitting in that State. Each party submits to the personal jurisdiction of those courts and waives all objections to that jurisdiction and venue for those disputes.

6.2 The failure of either party to enforce at any time any of the provisions of this Agreement, or the failure to require at any time the provisions of this Agreement to be complied with, shall in no way be construed to be a present or future waiver of such provisions, nor in any way affect the right of either party to enforce each and every such provision thereafter. A waiver shall only be binding upon a party when executed in writing by an authorized representative of that party. The express waiver by either party of any provision, condition or requirement of this Agreement shall not constitute a waiver of any future obligation to comply with such provision, condition or requirement.

6.3 This Agreement with accepted Quotes which are incorporated herein constitute the complete and entire agreement between You and SLL pertaining to the subject matter hereof, and all prior or contemporaneous agreements, publications, negotiations, discussions and understandings, collateral or otherwise, written or oral, between the parties relating thereto are merged into and superseded by this Agreement. The execution of this Agreement has not been induced by, nor does either party rely upon or regard as material, any representations, warranties, conditions or other agreements not expressly made in this Agreement. No modification or amendment to this Agreement with accepted Quotes is possible unless committed to writing and signed by authorised representatives of both SLL and the Licensee. No entity or person not a party hereto shall have any interest under this Agreement, or be deemed to be a third party beneficiary thereof.

6.4 Licensee may not assign its rights or obligations under this Agreement without the prior written consent of SLL. This Agreement shall endure to the benefit of and be binding upon the parties and their respective successors and permitted assigns.

6.5 If the whole or any part of a provision of this Agreement is void, unenforceable or illegal in a jurisdiction it is severed from the Agreement for that jurisdiction only. The remainder of this Agreement has full force and effect and the validity or enforceability of that provision in any other jurisdiction is not affected.

6.6 Nothing contained in this Agreement shall be deemed to constitute a party or any of its directors, officers, employees, representatives, or agents the partner, agent, franchisee, or legal representative of the other party or to create any fiduciary relationship for any purpose whatsoever. Except as otherwise specifically provided in this Agreement, nothing in this Agreement shall confer on a party or any of its representatives any authority to act for, bind, or create or assume any obligation or responsibility on behalf of the other party.

6.7 No party shall be deemed in default hereunder or liable for any loss or damage resulting from delays in performance or from failure to perform or comply with the terms of this Agreement due to any causes beyond its reasonable control, which causes include but are not limited to acts of God or the public enemy; riots and insurrections, war, terrorism, accidents, fire, strikes and other labor difficulties (whether or not the party is in a position to concede to such demands), embargoes, judicial action, lack of or inability to obtain export permits or approvals, necessary labor, materials, energy, utilities, components or machinery, acts of civil or military authorities.

6.8 This Agreement and any modification or amendment to it, including to any of its accepted Quotes, may be executed and exchanged by electronic means including but not limited to the License Assistant, scanned copies exchanged via email and facsimile.

6.9 Specifically, SLL and Licensee accept and agree that this Agreement shall be automatically extended to include all specific Licensed Product and terms and conditions as set forth in any Quote for Licensed Product that is provided by SLL to You, and that is accepted by You. Your acceptance of the Quotation must be committed to writing and signed by an authorised person or alternatively it can be demonstrated by Your use of a unique acceptance and authorisation code, that is associated with that Quotation, that You input when using The License Assistant. To be clear, SLL and Licensee accept and agree that this Agreement shall be automatically extended to include all specific Product and terms and conditions as set forth in any Quotation that references this Agreement and that is provided by SLL to You, and that is accepted by You.

6.10 If you are an organisation, Licensee hereby agrees and gives permission for SLL to publish Licensees name on SLL's website, but only where it will say words to the effect that Licensee is using the Product.

6.11 Licensee agrees to receive from SLL periodic correspondence and emails containing promotional literature on SLL's offerings, and also information on any bug fixes and any updates in relation to the Licensed Product.

6.12 SLL will provide to Licensee Support and any Product upgrades only if these items are specifically included in a Quote for Licensed Product. Licensee may purchase additional Product support services, however these must be the subject of a separate written agreement subject to terms negotiated and then settled by mutual agreement between the parties.

6.13 Notwithstanding anything in this Agreement to the contrary, You agree that SLL may disclose Your identity by name and address and contact information, and identify the Licensed Product licensed to You, to the extent required by SLL's agreement with its Partners and Authorized Distributors. You agree that SLL may also identify and disclose the existence of any executed License Agreements between SLL and Yourself, and any Licensed Product licensed to You, to other people using the License Assistant, to the extent required for them to also fulfil online transactions on behalf of Your organisation.

Product is NOT of USA origin and is NOT sourced from any country subject to EU or USA embargo.

6.16 Any use or attempted use of the Product in violation of the foregoing restrictions is a breach of this Agreement that will cause irreparable harm to SLL entitling SLL to injunctive relief in addition to all legal remedies. By downloading, installing, copying or using the Licensed Software, or by paying a license or other applicable fee, You acknowledge that You have read this Agreement, understand it, and agree to be bound by its terms and conditions.

6.17 Also see each of the accepted Quotes for Licensed Product referenced above and which forms part of this Agreement.

6.18 Survival. If the Agreement terminates for any reason, all definitions in this Agreement and the rights, obligations, general terms, disclaimers, limitations and restrictions under Preamble and Definitions and Sections 1; 2; 3; 4; 5; and 6 shall survive termination of the Agreement.
